**Re-Invitation for Online Bids for the Construction of Office building**



Ministry of Land Management Agriculture and Co-Operatives (MOLMAC) Province no.1 Biratnagar notify that all the bid offers received for the construction of Office building were deemed non responsive upon evaluation and re-invites E-bids from eligible bidders for the procurement of the construction of office building under National Competitive Bidding (NCB) procedures.

2. Eligible Bidders may obtain further information and inspect the bidding documents at the Ministry of land management agriculture and co-operatives province no.1 Biratnagar During office hour. or may visit **e-GP II Portal of PPMO websites www.bolpatra.gov.np/e-GP.**
3. Bids must be submitted electronically through e-GP II of PPMO website www.bolpatra.gov.np/egp on or before 2076/02/28 (11 June 2019). The bidders shall pay non refundable fee **Rs.3000.00 (Three Thousands Only) in Ministry of Land Management Agriculture and Co-Operatives, Ministry Code 70-135-130-1, Account No. 1000200010000 , Revenue Head 14229, Bank Name:- Rastriya Banijya Bank, Biratnagar** and submit scanned electronic copy of the bank receipt along with the all electronic bid files.
4. The bid must be submitted on or before 12:00 hour noon of 2076/02/28 (11 June 2019). Documents received after this deadline will not be accepted. The accepted e-bid shall be open in the presence of the bidders representatives who choose to attend at 14:00 hours on the last date of bid submission. Non-attendance of any or all the Bidders representatives shall not hinder the opening of the bids.
- Bids must be accompanied by bid security amount as stated in above table either in the form of bank voucher confirming cash deposit in **Ministry of Land Management Agriculture and Co-Operatives. Office Code:- 70-135-130-1, Account no - Pradesh kha-2 2120502000000**, Province Treasury Controller Office Province No.1 Dharuti Khata at Rastriya Banijya Bank, Biratnagar or a bid security issued by a commercial bank approved by (Nepal Rastriya Banijya Bank) validity for minimum of 120 days as prescribed format counting from the date of bid opening.
5. The bidder must submit the original copy of their e-bids within 7 days of last day of bid submission.
6. Pre-bid meeting shall be held on 2076/02/20 (3rd June 2019), 14:00pm at Ministry of land management, agriculture and co-operatives province no.1 biratnagar.
7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids any time without assigning reason, whatsoever.
10. Matters not covered by this notice and Bid Document, shall be in accordance with Public Procurement act, 2063 and Public Procurement Regulation 2064 and other prevailing rules and regulations.
